KU Leuven is a <i>sui generis</i> legal entity of a private law nature by virtue of the Basic Law of 12 August 1911 and pursuant to the publication of its founding act together with its Organisational Charter in the annexes to the Belgian Official Gazette of 1 July 1970.

Organisational charter (equivalent to "articles of association"):	In accordance with the Act of 12 August 1911 , the organisational structure of KU Leuven (including UZ Leuven) is governed by its Organisational Charter . The current version was approved by the Board of Trustees on 2 April 2020 and entered into force on 1 May 2020 (published in the Belgian Official Gazette on 22 April 2020 , p. 27.744 et seq.).
Representation:	<p>In accordance with Article 10 of the Organisational Charter, KU Leuven shall, for matters concerning UZ Leuven, be represented in and out of court by the Chairman of the UZ Leuven Management Committee (em. Prof. Dr. Mark WAER) and the UZ Leuven Executive Director (Prof. Dr Wim ROBBERECHT).</p> <p>On the proposal of the Management Committee UZ Leuven, the Board of Governors of KU Leuven granted power of attorney to a series of specifically designated representatives (the most relevant of which are bundled in the private power of attorney</p>

	arrangements for UZ Leuven) with respect to well-defined matters concerning the operation of UZ Leuven, this in accordance with Article 11 of the Organisational Charter.
Governing body:	<p>The UZ Leuven Management Committee is responsible for the organisation, operation and management of KU Leuven University Hospitals, as stipulated in the Coordinated Hospitals Act [4], with the exception of the appointment of the company auditor, for which the KU Leuven Board of Governors is competent in accordance with Article 27 of the Organisational Charter.</p> <p>The current composition of the UZ Leuven Management Committee and the UZ Leuven Executive Committee is always available at www.uzleuven.be.</p>
