<b>Legal entity:</b>	<b>UZ Leuven</b> constitutes one of the three components of <b>KU Leuven</b> , as defined in its <a href="#">Organisational Charter</a> . KU Leuven is a <i>sui generis</i> legal entity of a private law nature by virtue of the <a href="#">Basic Law of 12 August 1911</a> and pursuant to the publication of its <a href="#">founding act</a> together with its Organisational Charter in the annexes to the Belgian Official Gazette of 1 July 1970.
<b>Register of Legal Entities:</b>	Business court of the judicial district of Leuven
<b>Organisational charter (equivalent to "articles of association"):</b>	In accordance with the <a href="#">Act of 12 August 1911</a> , the organisational structure of KU Leuven (including UZ Leuven) is governed by its <a href="#">Organisational Charter</a> . The current version has been adopted by the <a href="#">Board of Trustees</a> during its session on April 2, 2020 as modified on 7 July 2022 and 21 December 2023 (published in the <a href="#">Belgian Official Gazette on January 31, 2024</a> , p. 12.311 et seq.).
<b>Representation:</b>	<p>In accordance with <a href="#">Article 10 of the Organisational Charter</a>, KU Leuven shall, for matters concerning UZ Leuven, be represented in and out of court by the Chairman of the UZ Leuven Management Committee (Koen VAN GERVEN) or the UZ Leuven Executive Director (prof. dr. Paul HERIJGERS).</p> <p>On the proposal of the Management Committee UZ Leuven, the Board of Governors of KU Leuven granted power of attorney to a series of specifically designated representatives (the most relevant of which are bundled in the private power of attorney arrangements for UZ Leuven) with respect to well-defined matters concerning the operation of UZ Leuven, this in accordance with Article 11 of the Organisational Charter.</p>

<b>Governing body:</b>	<p>The UZ Leuven Management Committee is responsible for the organisation, operation and management of KU Leuven University Hospitals, as stipulated in the Coordinated Hospitals Act [1], with the exception of the appointment of the company auditor, for which the KU Leuven Board of Governors is competent in accordance with <a href="#">Article 27 of the Organisational Charter</a>.</p> <p>The current composition of the UZ Leuven Management Committee and the UZ Leuven Executive Committee is always available at <a href="http://www.uzleuven.be">www.uzleuven.be</a>.</p>
<b>Ultimate Beneficial Owners (UBO):</b>	Legal entities <i>sui generis</i> do not fall under the scope of the Law of 18 September 2017 on the prevention of money laundering and terrorist financing and on the restriction of the use of cash. Consequently, no beneficial owners were registered in the UBO register for KU Leuven.
